Thank you for taking an interest in the Woodbury City/Logan Twp Police Department. Please read this application package carefully and review it with your child who is interested in attending the Woodbury-Logan Advanced Junior Police Academy.

Please understand that the Woodbury City-Logan Twp Junior Police Academy is for individuals who have an interest in police service, community, government, and/or a general appreciation for public service. The Jr. Police Academy is not a “boot camp” or a type of “scared straight” program for young people who purposely do not follow rules.

The purpose of this advanced class is to provide further learning opportunities to those who have attended previous academy classes. This class is being presented for those who wish to challenge themselves with what they learned in pervious basic academy settings. Children will need to write a one page paper, outlining why they wish to attend the advanced class, which must be submitted with this application. This is due to limited space available, due to more hands on exercises.

Children attending the Jr. Police Academy must at all times adhere to the rules enumerated on Page 4 of this application package. I understand that if my child does not follow the rules while at the Jr. Police Academy he/she he will not be permitted to complete the academy.

I understand that at least one parent or guardian must attend one of the orientation nights as listed in this application package. I also understand that the location in which I drop my child off may not be the same every day and I will receive specific instruction of the exact location where your child will have to be dropped off.
